#### Recap 2019-20-21

- 2019-20 ended abruptly in March of 2020 where we had no completion to the league playoffs
- All three teams otherwise had successful Tournament results especially at the Cruiser Cup (Gold/Silver/Silver)
- It was great to see support from all of our teams cheering each other on at tournaments and in league games when possible
- There was great uncertainty through the beginning months of the pandemic and chances to hold an AGM were postponed until a better manageable time as now
- Last season was again cut very in November 2020, we were only able to hold practices
- Fees paid last season carry a part credit to this season, the cost to run the show was low and only \$75 was charged to participants to cover insurance and the cost of ice.

### **Ice Details**

- We are registered for our ice with the City of Hamilton for 2021-22

- Record keeping of the attendance of all participants must be done by each team's designated Health Officer this includes player/pusher/coach/trainer/spectator and any visiting team's people too
- OSHA has mandated proof of vaccination to participate in any OSHA sanctioned event –further details can be found on the OSHA website

## **OSHA Report**

- Rules have been updated and will be available on the OSHA site soon
- 2021-22 league structure is TBA for now we will only practice
- A Referee clinic video is to be shot this season to assist new referees and keep consistency in their judgements
- OSHA player/participant fees (\$30-\$35) have been eliminated for 2021-22 but the cost of insurance (\$35) has increased which is some savings for the HDSHA
- The Game Time Brew Co. partnership is expected to generate substantial funds for OSHA in the next few years OSHA can expect 1% of Puck Drop Pilsner sales to help subsidize insurance, player fees, Champions Day costs etc., if the revenues are great we could see some fees waived...
